**Developer Charge** A fee of \$3,000 (annually adjusted by inflation) will be charged to the Developers or individuals for each unit to be connected to PDMU Corp. water and sewer system at the time the project drawings are approved by PDMU.

**Prorated Bills** Upon change in ownership, permanent disconnection or initial connection of a customer, the minimum bill will be prorated over the billing period.

**Terms of Payment** Bills are rendered net and are due and payable within twenty (20) days from date of presentation.

**Terms and Conditions** Service under this rate schedule is subject to the Company’s Rules and Regulations on file with the Excavation, Demolition and Pipes Directorate (DDET), Department of Transportation and Public Works (DTOP).

**Service Availability Charge** A service availability charge of the applicable minimum bill as specified in this rate schedule will always be in effect for a maximum of 13 months if service is temporarily disconnected. After the 13 months period a permanent disconnection will be in effect, removing the water meter and discontinuing the service availability charge.

**Reconnection Charge** A fee of \$50.00 will be charged for reconnecting service which has previously been temporary disconnected due to lack of payments. If the service has been permanently disconnected, a fee of \$200.00 will be charged to reinstall the water meter and provide the service.
